NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution read with the Notification No. F. 5/4/65-GP dated the 11th January, 1965 of the Ministry of Home Affairs, Government of India, the Lieutenant-Governor, Pondicherry, hereby makes the following rules regulating the method of recruitment to Class III and Class IV posts in the Office of the Lieutenant-Governor and Raj Nivas Household Establishment, Pondicherry.

- SHORT TITLE: These rules may be called the Government of Pondicherry, Office of the Lieutenant-Governor and Raj Nivas Household Establishment (Class III and Class IV Posts) Recruitment Rules, 1973.
- 2. APPLICATION: These rules shall apply for recruitment to the posts in the Office of the Lieutenant-Governor and Raj Nivas Household Establishment, Pondicherry, specified in the column (1) of the Schedules I to III hereto annexed.
- 3. NUMBER OF POSTS, THEIR CLASSIFICATION AND SCALES OF PAY: The number of the said posts, their classification and the scales of pay attached thereto, shall be as specified in columns (2) to (4) of the respective Schedules.
- 4. METHODS OF RECRUITMENT, AGE-LIMIT AND OTHER QUALIFICATIONS: The methods of recruitment to the said posts, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the respective Schedules:

Provided that the upper age-limit specified for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the general orders of the Lieutenant-Governor issued from time to time.

- 5. DISQUALIFICATIONS: (1) No person who has more than one wife living or who, having a spouse living, marries in any case in which such marriage is void by reason of its taking place during the life time of such spouse, shall be eligible for appointment to any of the said posts.
- (2) No woman whose marriage is void by reason of the husband having a wife living at the time of such marriage or who has married a person who has a wife living at the time of such marriage, shall be eligible for appointment to any of the said posts:

Provided that the Lieutenant-Governor may, if satisfied that there are special grounds for so ordering, exempt any person from the operation of this rule.

6. POWERS TO RELAX: Where the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he may, by order, relax any of the provisions of these rules with respect to any person.

7. SAVING: Nothing in these rules shall affect reservations and other concessions required to be provided for Scheduled Castes and Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
